It also leads you to produce large amounts of urine. While the terms "diabetes insipidus" and "diabetes mellitus" sound similar, they're not related.

Central diabetes insipidus (CDI) is the end result of a number of conditions that affect the hypothalamic neurohypophyseal system. The known causes include germinoma/craniopharyngioma, Langerhans cell histiocytosis (LCH), local inflammatory, autoimmune or vascular diseases, trauma resulting from surgery or an accident, sarcoidosis, metastases and midline cerebral and cranial malformations.

In case of inadequate thirst, desmopressin is the drug of choice. Pharmaceutical therapy for diabetes insipidus includes subcutaneous, nasal, and oral preparations of vasopressin analogues, as well as chlorpropamide, carbamazepine, clofibrate, thiazides, and indomethacin (limited efficacy).

Diabetic Causes of Decreased Urine Osmolarity Diabetes insipidus - excess urine output, typically dilute urine; usually blood glucose levels aren't changed Nephrogenic DI - insensitivity to ADH despite release from CNS Neurogenic DI - affecting the hypothalamus, lack of ADH

When nephrogenic diabetes insipidus is caused by mutations in the AQP2 gene (about 10% of the inherited cases of nephrogenic diabetes insipidus), it can have either an autosomal recessive or, less commonly, an autosomal dominant pattern of inheritance. I In autosomal recessive inheritance, both copies of the gene in each cell have mutations.

The cause of diabetes insipidus is problems with antidiuretic hormone (vasopressin). Either the body does not make enough which affects the balance of fluids in the body, or the body produces adequate amounts but the kidneys do not respond to it. The cause of most cases of central diabetes insipidus is unknown.
