Class Action Settlements & Rebates

New Tax On Lawsuit Settlements -- Legal Fees Can't Be Deducted

The standard legal fee for plaintiffs' attorneys is 40% plus expenses. (In mass tort cases like Zantac with thousands of plaintiffs, "expenses" tend to be minimal.) So if a plaintiff gets a \$100,000 settlement, the plaintiff can expect to receive close to \$60,000 (60% of the total).

Zantac Settlements - How Lawyers Calculate The Payout

Many plaintiffs are taxed on their attorney fees too, even if their lawyer takes 40% off the top. In a \$100,000 case, that means paying tax on \$100,000, even if \$40,000 goes to the lawyer.
